

RESPONSIBILITY AND WAIVER OF LIABILITY AGREEMENT

I understand and acknowledge the danger associated with the discharge of firearms and the shooting sports conducted on the Old Vermilion Trail Hunting Preserve & Sporting Clays LLC property located at 6980 Old Vermilion Trail, Duluth, Minnesota.

As consideration for and as a condition for use of property, facilities and services at the Old Vermilion Trail Hunting Preserve & Sporting Clays LLC (OVT) and for other good and valuable consideration, (1) I hereby, ASSUME THE RISK OF INJURY AND LOSS associated with my presence on, and use of the OVT's property; (2) I, and for my heirs, next of kin, and assigns, HEREBY RELEASE, DISCHARGE, AND GIVE UP, ANY AND ALL CLAIMS AGAINST THE OVT and/or ITS OWNERS, DIRECTORS, EMPLOYEES, AGENTS, and/or ASSIGNS FOR INJURY, DEATH OR PROPERTY DAMAGE that arises out of the negligent act(s) or omission(s) of the OVT and/or its owners, directors, employees, agents and/or assigns, as it relates to my use of its property, the condition of its property, or activities being conducted on its property regardless of whether I am participating in those activities, and I hereby agree and covenant on behalf of myself, my heirs, next of kin, and assigns, not to sue the OVT, its owners, directors, employees, agents, and/or assigns for injury, death, or property damage; and (3) I AGREE TO INDEMNIFY, AND HOLD HARMLESS THE OVT AND ITS OWNERS, DIRECTORS, EMPLOYEES, AGENTS and/or ASSIGNS FROM SUCH CLAIMS AND PROMISE NOT TO COMMENCE LEGAL ACTION FOR SUCH CLAIMS. The foregoing is to be construed broadly to provide a waiver and release of claims to the maximum extent allowable by law, and such waiver and indemnifications shall be perpetual in duration.

I am solely responsible for injury or damage to property caused by my negligence or fault or the negligence or fault of the minor children for whom I am the parent or legal guardian of while we are on the OVT's property. I further represent that neither I nor any minor child participating in shooting activities hereby are legally prohibited from possessing or using any of the firearms that I or they will bring onto the OVT's property.

I acknowledge the right of the OVT's management and employees to immediately terminate my participation in activities for my failure or the failure of my guests, or minor children or minors for whom I am the legal guardian to fully comply with the Old Vermilion Trail Hunting Preserve & Sporting Clays LLC Safety Rules (OVT Rules) or for any other reason at any time. I further understand and agree that my noncompliance with the OVT Rules and the directives of its management may result in the revocation of my shooting privileges.

I have received, a copy of the OVT Rules, and I have read, understood, and agree to abide by the OVT Rules as currently written and as may be amended from time-to-time. I certify that I have read the foregoing, that I fully understand it, and that I have signed it of my own free will. I understand that by signing below, I am entering into a contract with the OVT by which I am releasing it from liability and that I am giving up certain rights of my minor child(ren) or ward(s) to bring certain claims as a condition of and as consideration for use of the property, facilities and services at the OVT and the rights and privileges associated therewith.

OLD VERMILION TRAIL HUNTING PRESERVE & SPORTING CLAYS LLC RULES

Old Vermilion Trail Hunting Preserve & Sporting Clays (OVT) is a safe, friendly, and respectful place for members, non-members, and visitors to gather together in the spirit of fellowship, relaxation, and recreation for friendly enjoyment of the shooting sports. All members, non-members, staff, guests, and visitors are expected to conduct themselves at all times in a manner that:

- Creates an environment that is reflective of personal integrity, respect, and safety for the shooting sports. These qualities must be reflected on the shooting ranges, in the clubhouse, and everywhere else on OVT property.
- Promotes good sportsmanship.
- Is vigilant about safety. Safety is everyone's responsibility. Anyone who observes an unsafe behavior, unsafe condition, or potential safety hazard, is encouraged to report such to OVT management.
- Deals with OVT fairly and agrees that the "Membership" target prices are for members only, and non-members shall pay the "non-member" target price. (e.g., members shall not share/borrow their Membership Card with non-members)

GUN SAFETY AND GENERAL RULES

1. You are responsible for your safety and must behave in a safe and responsible manner at all times.
2. Alcohol, illegal drugs, prescription drugs that may impair motor skills or cognitive abilities, and shooting DO NOT mix. No one is allowed to shoot who has previously consumed alcohol, illegal drugs, or a prescription drug that impairs motor skills or cognitive abilities on the day of shooting or who appears to be under the influence of alcohol or such drugs.
3. All shooters and observers must wear hearing and eye protection while present on any shooting field or range.
4. All uncased guns must be carried unloaded with the action open, empty of shells, and with the muzzle pointed in a safe direction at all times. Guns must be carried to shooting stations unloaded. Do not load your gun until you have entered the station.
5. Shooting at unauthorized targets is prohibited, that includes shooting at "chips" off of broken clays.
 - **All wildlife is protected at all times.**
6. When a delay occurs at a station, all ammunition must be removed from the gun and the action must be open.
7. Only authorized persons are allowed near the clay target machines.
8. Shot size no larger than 7 ½ is allowed. Use Target Loads only, no hunting loads allowed.
9. **No more than 2 shells may be loaded in any shotgun at any time.**
 - When shooting sporting clays, only 2 shells may be loaded at a time.
 - When shooting Trap, only one shell may be loaded at a time.
 - When shooting Skeet, 2 shells may be loaded for either singles or double except at station eight (8), where only one shell may be loaded for each house. Single targets may only be shot at once.
10. All shooters, age 12 – 18, are required to have passed a Gun Safety Program and provide proof as such upon request by OVT. No one under the age of 12 is permitted to carry or shoot any type of gun at OVT.
11. Carefully observe and follow all posted safety signs.
